Application form for community grants

Please note that:

- Airfield museums and similar venues may use this form to apply for up to £500, for activities that will attract more visitors or allow better engagement with underserved groups.
- Other community groups may use this form to apply for up to £250 for excursions to airfield museums and similar venues, including the costs of appropriate transportation, admission costs and refreshments. Excursion grants will only be considered for groups facing demonstrable disadvantage, for example, the elderly, disabled or those affected by poverty or hardship.
- The applicant organisation must be a non-profit organisation such as a trust, charity, CIC etc. Grants are not available to individual persons or private companies. Your organisation must have its own bank account which requires two unrelated people to authorise cheques and make withdrawals
- If the grant is used as part-funding for an activity, the remaining funding must already have been secured in order for ABCT to consider your application
- Any ABCT grant must be publicly acknowledged with our logo, for example on an information leaflet or on your website. Funding may be subject to other conditions as agreed with your organisation.
